ORDER OF SUSPENSION OF CERTAIN ATTORNEYS FOR FAILURE TO COMPLY WITH CONTINUING LEGAL EDUCATION REQUIREMENTS

The Indiana Commission for Continuing Legal Education ("the Commission") has notified this Court of certain attorneys who remain delinquent with regard to compliance with certain continuing legal education ("CLE") requirements for the educational period ending December 31, 2009, either because they failed to meet extended deadlines they received to complete their continuing legal education requirements and/or pay applicable delinquency fees, *see* Ind. Admission & Discipline Rule 29, § 8(e), or because they resumed active status less than one year after having assumed inactive status, *see* <u>id.</u> § 8(d), namely:

The Clerk is also directed to post this order to the Court's website.
